

Annual Accreditation Fee and Other Fee Schedule

The annual accreditation fee is due on **November 30th** in each year for the following year.

Note: HST will be added to the fees below.

Annual Accreditation Fee

For practices with a certificate of accreditation for 5 years:

Practice Type	Annual Fee
Practice with Essential Standards only	\$125
Practice with Essential Standards and ≤ 5 Additional Scope of Practice Standards	\$135
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$145

For practices with a certificate of accreditation for 3 years:

Practice Type	Annual Fee
Practice with Essential Standards only	\$185
Practice with Essential Standards and ≤ 5 Additional Scope of Practice Standards	\$200
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$215

For practices with a certificate of accreditation for 2 years:

Practice Type	Annual Fee
Practice with Essential Standards only	\$260
Practice with Essential Standards and ≤ 5 Additional Scope of Practice Standards	\$285
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$310

For practices with a certificate of accreditation for 1 year:

Practice Type	Annual Fee
Practice with Essential Standards only	\$485
Practice with Essential Standards and ≤ 5 Additional Scope of Practice Standards	\$535
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$585

New Practice Inspection Fee

The new practice inspection fee includes new practice inspection and medical records check.

Practice Type	Fee
Practice with Essential Standards only	\$450
Practice with Essential Standards and ≤5 Additional Scope of Practice Standards	\$500
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$550

Unannounced Inspection Fee

This would be the cost associated with having to conduct an inspection due to terms, limits or conditions (TLC) placed by Accreditation Committee or a Registrar's Investigation (O.Reg.1093 s.50).

Practice Type	Fee
Practice with Essential Standards only	\$450
Practice with Essential Standards and ≤5 Additional Scope of Practice Standards	\$500
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$550

Incomplete Inspection Fee

This fee will be charged to practices where the inspector is unable to complete the inspection due to failure to comply with a major requirement. (e.g., x-ray machine not installed, surgical suite still being constructed, etc.)

Practice with Essential Standards only	\$450
Practice with Essential Standards and ≤5 Additional Scope of Practice Standards	\$500
Practice with Essential Standards and ≥ 6 Additional Scope of Practice Standards	\$550

Penalty Fees

Penalty Type	Fee
Cancellation or re-scheduling of an inspection with less than 48 business hours notice	\$300
Failure to notify changes to the practice (O.Reg.1093 section 13)	\$200
Late annual accreditation fee payment	\$200
